

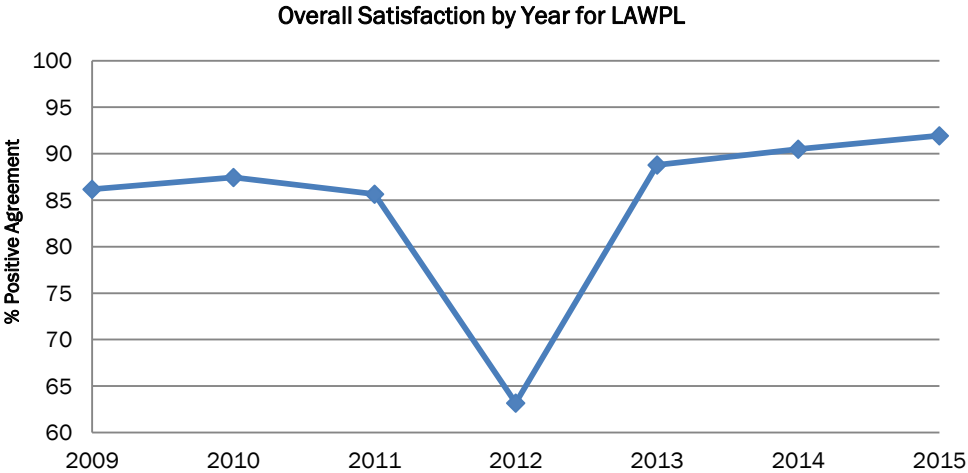
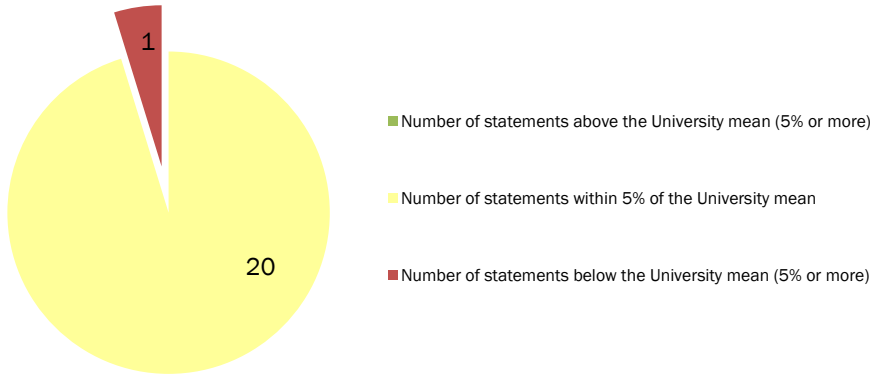
National Student Survey 2015 Dashboard for LAWPL

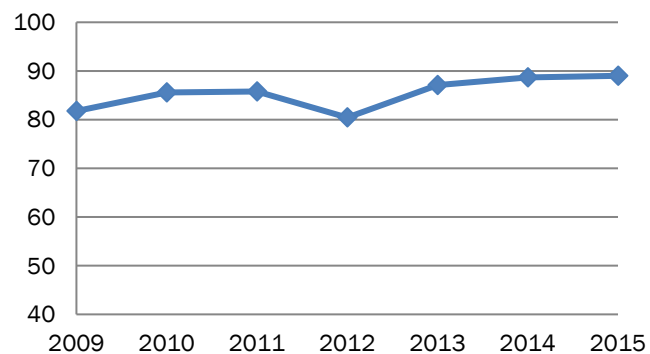

The library resources and services are good enough for my needs.	87%	-4%

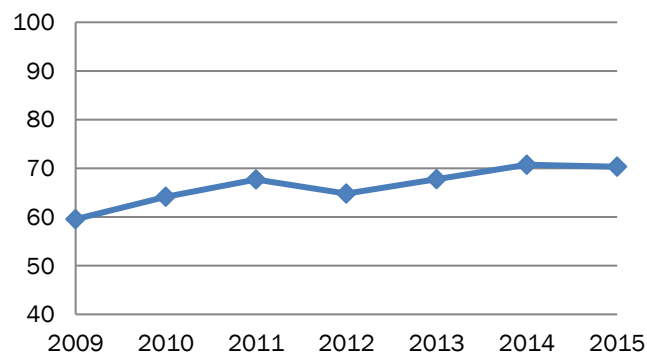
Seven Year Thematic Performance LAWPL

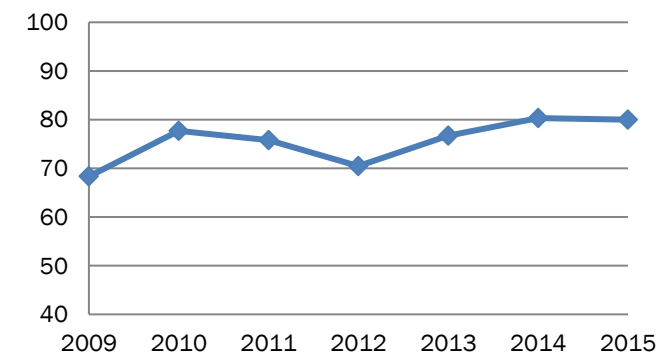
