FUNDING FOR TAUGHT POSTGRADUATE STUDY

There are many ways to fund your postgraduate studies, depending on the type of postgraduate course or programme you will be pursuing.

Scholarships

Master's Excellence Scholarships

This scholarship is open to students with a home fee status who intend on studying one of our Taught Master's Degrees. It is worth £3000 and it's usually awarded in the form of a tuition fee discount. Therefore, you need to submit an application to study at Cardiff University and be made an offer before your fee status can be confirmed. Your fee status is determined in accordance with the Fees Regulations. Please consult the UKCISA website regarding fee status in Wales.

Only complete full-time and part-time postgraduate taught programmes that lead to a Master's degree are eligible. The programmes eligible are: a full-time programme leading to a taught Master's degree, a part-time programme leading to a taught Master's degree, MRes Biosciences, and MRes Stem Cell Neurobiology.

If you are thinking of studying part-time, you will receive 50% of this scholarship in your first year and 50% in your second year. If you are thinking of studying a full-time programme which lasts longer than one year you will not receive funding for additional years from this scholarship scheme or its successor.

Bar Training Course Scholarship

Our 2021 Cardiff University Bar Training Course Scholarship is available to any

student who has been awarded a firstclass degree.

Loans and grants

UK Government master's funding If you are starting your master's degree in September 2021 or later, you may be eligible to apply for the UK Government postgraduate funding to support your study at Cardiff University.

Bursaries

Alumni Discount Scheme

The alumni discount is available for all master's programmes in Cardiff Business School, as well as conversion courses in subjects including journalism, geography and planning, and creative writing, and master's programmes in clinical optometry, neuroimaging, education, global cultures, history, philosophy and translation.

FUNDING FOR INTERNATIONAL STUDENTS

Vice-Chancellor's International Scholarship

The University offers over £2M in funding to undergraduate and postgraduate international students through our range of scholarship schemes.

Vice-Chancellor's EU Scholarship

There are offer awards of £5,000 to EU, EEA and Swiss students through this new scholarship scheme.

Vice-Chancellor's China Scholarship Scheme

Awards of £2,000 - £5,000 are available to all Chinese students at undergraduate and postgraduate level.

Vice-Chancellor's International Scholarship for Research Excellence

A full tuition fee funding and an annual stipend to support self-funding full-time PhD international students for up to three years.

Cardiff India scholarships

In recognition of the outstanding talent of our Indian students, a range of highly prestigious postgraduate scholarships are available.

Alumni Discount Pilot Scheme

An alumni discount scheme for all master's programmes offered by Cardiff Business School and conversion courses in subjects including journalism, geography and planning, and creative writing.

Cardiff University Marshall Scholarship

Marshall Scholarships finance US nationals of high ability to study postgraduate programmes at UK universities.

Chevening and Global Wales Scholarships

Cardiff University is a popular destination for Chevening Scholars and do boast of a vibrant chevening network of students.

Commonwealth Master's Scholarship Programme

Scholarships are available for students from developing Commonwealth countries who would not otherwise be able to study in the UK.

CONACYT Scholarship

CONACYT (Consejo Nacional de Ciencia y Tecnología) offers scholarships to Mexican students enrolling on postgraduate courses.





Fulbright-Cardiff University scholarship

If you are an US citizen, you can apply for this annual scholarship.

Law Transfer Scholarship

The Cardiff University Law Transfer Scholarship is available to eligible students transferring into either year two or year three of our LLB programmes.

PhD Research Scholarships

If you are looking to take up a Doctoral programme, funding is available from both the University and external organisations.

The Beacon Scholarship

This lucrative scheme is open to applicants to all undergraduate courses (excluding medicine) from Kenya, Tanzania and Uganda.

Visiting scholars funding schemes

Cardiff University offers two visiting scholar funding schemes - Fulbright and the China Scholarship Council.

Global Wales Postgraduate Scholarship

This prestigious new scholarship programme, offered in collaboration with Study in Wales, is open to postgraduate students from the USA, India, Vietnam and the European Union.
